CHAIRMAN:

and the Senate is now called to order.

The Committee gets its authority for the holding of these Sessions from a Resolution passed in the House and the Senate. The Committee is authorized to take evidence from citizens on the White Paper. The terms of reference, therefore, is only relevant to the White Paper and we are not concerned about whether we want independence or whether we don't want independence. We are concerned with the terms of the White Paper.

Secondly, these hearings under the Standing Orders of the House of Representatives should not be published until the Committee tender its report, and anyone doing so will lay himself open to contempt of the House; that is a criminal charge. Having said that, we will now begin our Session here in Corozal Town. The Members of the Committee you all know, and there are two joint Chairmen.

Mr Luis Puc, Chairman of San Joaquin Village Council

CHAIRMAN:

Do you represent the Village Council there?

Mr Verde:

Yes, sir, and the rest who are here too. • I am the

CHAIRMAN:

Very well, go ahead.

Mr Verde:

We have had several copies of the White Paper circulated around over the past ten/twelve days. We have met occasionally, and we are here to support the White Paper in its full, but begging for an amendment.

CHAIRMAN:

Tell us where you want your amendment.

Mr Verde:

In the Preamble. We acknowledge the Supreme Authority of God. We beg that we put into the New Constitution

of Belize the Belizean Prayer.

Second, we acknowledge that every Nation should have its National Anthem. We beg that the Belizean National Hymn 'Lands of the Gods' be included in the

New Constitution of Belize.

Third, every country has a flag of its own and all propose that the Belizean Flag, the blue and white with the Coat of Arms of the Baymen and the same that appears in our money be the Coat of Arms in the blue and white flag for Belize and that they be included in the New Constitution.

Fourth; noting also Article 43, we propose that it be more carefully watched and that Belizeans in this case,

in this particular case, may be referred as a true Belizean, born in Belize from parents of Belizean Here we see a loophole that will not provide this privilege.

CHAIRMAN: Parents should also be Belizean. This is for the

CHAIRMAN: Mr Puc: Yes. What would you like to say?

Mr Chairman, I would like to endorse that the proposals include the national flag, anthem and the prayer.

I further endorse the amendment already suggested for Section 43.

Section 16 - Citizenship... the Governor-General.

I would like the Governor-General to be a Belizean citizen by birth and that both parents be Belizean by birth also.

Apart from all that, I endorse the White Paper as it is.

CHAIRMAN:

Thank you very much for coming before this Committee.

Mr Idelfonso Gomez, Chairman, Executive Committee, P.U.P. Corozal North.

CHAIRMAN:

Yes. Go ahead.

Mr Gomez:

As we look into the Preamble, one thing I would like to be included as others have said, but for reasons. First of all, we would like the National Flag, who blue and white with the sub umbra flured so as to be known and that should be the flag to represent all Belizeans at home and abroad. With that also, I would like something to be included with the National Flag, and that is the National Anthem. As all nations in the world know and they are distinguished many a times not by their flag, but with their anthem and that is why I would like Belize to be known. So, therefore, I would like the National Anthem to be included also.

As you know Belize is a country very democratic and it has all sorts of religion; so, therefore, I would like the National Prayer to be included also. As we look into Section 12(b) "Any other person who has been resident continuously in Belize for a period of five years immediately prior to the day of independence". I, therefore, suggest that before any alien residing in Belize five years be given citizenship as a Belizean they should each be screened properly before that is granted.

CHAIRMAN:

That would be in the law itself.

Mr Gomez:

I understand.

All the Representatives of the National Assembly should be sons of the soil of their mother and father

also.

Above all, I stand for the White Paper as it is, but with these amendments.

CHAIRMAN:

Thank you, Mr Gomez, for coming before the Committee.

Mr Gomez:

Do you want to write the names of the Executive

Committee?

CHAIRMAN:

Yes, we could do with that, indeed.

Mr Gomez:

They are: Lucia Antonious, Avelio Ake,

CHAIRMAN:

Yes, Mr Ayuso, what will you tell us about the

White Paper?

Mr Ayuso:

With your permission, may I begin with this?

CHAIRMAN: Mr Ayuso: No. I would like your comments on the White Paper. Honourable Gentlemen, please refer to Page 1, section (c) and just to close the word in between and the last words where it says "believe that the will of the people shall form the basis of government in a democratic society in which the government is freely elected by universal adult suffrage". Now, in there I would suggest - I do propose that the following amendment be considered "and no re-election after serving for two five-year terms" after the word "suffrage", and including all the balance.

And I beg to add that this proposed amendment is in relation to Amendment 22 (ratified February 27th,

relation to Amendment 22 (ratified February 27th, 1951)Section 1 Article VII, the Constitution of the United States of America.

CHAIRMAN:

You add that, but in the United States Constitution, you can go on serving, up to now, for as long as they elect you, Mr Ayuso.

Mr.Ayuso:

00

I am talking about the President.

CHAIRMAN:

You should have said that.

Mr Ayuso:

Only for President, indeed, like in Mexico. No

re-election.

CHAIRMAN:

Here we are talking about a Parliamentary System - Representatives, no President.

Mr Ayuso:

Well, since there is no reference made to the Presidency, I thought of inserting it.

CHAIRMAN:

But this is not a Republic; this Constitution envisions a Representative Parliamentary Democracy.

Mr Ayuso: CHAIRMAN:

I do agree with that. It is only my suggestion. You make your point. We are here to point out

whether it is workable, you know.

Mr Ayuso:

Now, Part (2), vide page ?, (e). It says there "requires policies of state which protect and safeguard the unity, freedom, sovereignty and territorial integrity of Belize; which eliminate economic and social privilege", and it goes on, up to "nations". All those things I agree with, but I beg to comment on this. It says, referring to "eliminate economic and social privilege" to "nations"; I beg to say that this provision is commendable, but bitter experience has proven several times, during the Colonial era, that it has not been executed accordingly. Part 3 Section 3... "Regardless of race"; it begins there saying "Regardless of race". I beg to suggest to add the words "Spanish language" in between "place of origin" and "race" up to "freedoms". Because of English being the only official means of communication throughout Belize, the Mayas, the Mestizos, who generally use the Spanish Language as their only means of making themselves understood are at a great disadvantage.

Part (4) Page 3. Again, "the human rights and fundamental freedoms of the individual prescribed by the Constitution shall be defined and qualified in order to ensure that the enjoyment of these rights and freedoms by one individual does not prejudice the rights and freedoms of another nor damage the public interest." Now in between there I am suggesting this - I do suggest that explicit mention and insortion be made of these basic human rights and fundamental rights shall be consolidated and executed, strictly within the interpretation of the device called "Separation of Powers" as mentioned in The British Approach to Politics by Michael Stewart, Page 23, under the heading 'The Defence of Liberty';

and I quote: "The real defence for British liberty lies in the arrangements which make it difficult for a Government ever to become strong enough to twist the Constitution towards dictatorship without provoking revolt. Three powers are necessary for organizing a State: Legislative power to make laws; Executive power to carry them out; Judicial power to apply the law to particular problems. One view is that if these powers are placed in separate hands no one body of people will be strong enough to be tyrannical, and each power, jealous for its own authority, will keep watch on the others".

The "separation of powers" may not be an absolute safeguard; yet, I think that this device could be the lesser of two evils.

Page 8 - Part 15 "Any person who by birth or otherwise becomes a Belizean citizen, shall have the status of a Commonwealth citizen." I understand that I would still be categorized as a 'British Subject' if I would get residenship in England, inspite of an Independent Belize. The Queen's constitutional position in a Dominion is substantially the same as in this country, though the work must be done by a Governor-General; Her Title in a Dominion will describe Her explicitly as Queen of New Zealand. The people of the Dominions are British Subjects, but have their own laws as to citizenship. India is a Republic with a President at its head: its people recognize Elizabeth II, not as their Queen, but as Head of the Commonwealth; they are not British subjects but would become such if they came to live in this country (England) from the British Approach to Politics by Michael Stewart, Page 37).

HON. S. MUSA: Your proposal there is to change it to British subject?

Mr Ayuso: No. On the contrary.

CHAIRMAN: What are you proposing?

Mr Ayuso: I just don't like that thing there -in union with the Commonwealth, indefinitely.

CHAIRMAN: You don't want Belize to be a part of the Commonwealth?

Mr Ayuso: Yes, indefinitely.

Page 9, Part 16 - "There shall be a Governor-General of Belize who shall be a citizen of Belize". I agree with that up to "otherwise"; but this is what I have to say: inasmuch as I do appreciate what England has done for Belize, giving us her language and her Judicial system of laws, etc. yet, sincerely and honestly, I do not think that this Monarchical Process is in complete rapport with our hemispheric neighbourhood. Even the great United States of America, Mexico, Guyana and other American nations, once independent, severed their close relations with their former imperialistic masters; and adapted the Republican system, which for centuries has been the axiomatic foundation of liberty, fraternity and equality. From page 9 onwards, the Governor-General's powers take priority. I would venture to state, Honourable Gentlemen, that our present Belizean Government has my entire confidence that it drafted this Proposed Constitution with full cognizance of all the facts at its disposal that would, undoubtedly, enhance the security and independence of our entire nation. But, notwithstanding my approval of the Monarchical System, now I would still hope and trust that whenever it is convenient and safe for Belize, we as a free people, adapt the Republican system, forever. Only thus, can we acquire our economic, social and political identity within this competitive world. And, in conclusion, Members of this Honourable Select Committee, I do appreciate the contribution that you all are making towards the final compilation of various ideas, thoughts, notions and general proposals emanating from different segments of our Belizean Society; and do express my gratitude for the attention and patience you have granted me.

Mr Ayuso:

I permit you. I thank you.

I noticed that within the White Paper, Honourable Gentlemen, the system of Education was not given; what should I say; I won't say 'much thought'

because you are thinking people. But it doesn't mention much. I would suggest that as far as education is concerned so as to unify our people, so as to think Belizean, nationally Belizeans, we should standardize our text books. We should have one syllabus, one curriculum. We should not have books being bought or suggested by various religious denominations. People buy books, for example, this year and next year they can't use it because the denomination has changed the books. Such things cause havoc on the economic side of our people. The standardizing of our text books would make Belizeans people think in terms of Belize and not in terms only of the United States. Are you proposing that we put that in the

CHAIRMAN:

Mr. Ayuso:

Yes, indeed. I am suggesting that education embodies the standardization of all text books and also that those tect books should be both in English and Spanish as the two predominant languages in Belize; and priorities should be given to them because the North has played its role and is living up to its end, and it should be recognized. We should have more ecumenical schools like Corozal Community College, like Stann Creek Ecumenical College.

You want us to put that in the Constitution?

CHA IRMAN: Mr. Ayuso:

No. No. That we understand.

Constitution?

CHA IRMAN:

HON. V. COURTENAY: Mr. Chairman, with your permission, before you leave the subject of Education. You are not here suggesting that the Church/State policy of Government should be discontinued? Eventually; not discontinued completely. Allow Mr. Ayuso:

the church to have their own private schools but let government eventually take over and have state schools. I am not saying that we should deny them the right to have church schools, like in Mexico, like in the United States. They have a right to have schools, that is, the denominations; but let the state step in and say 'this is our schools and this is what you should teach: because that is one of the means that they use for dividing our people and we don't want that anymore if Belize is going to be independent and I trust that it is going to be independent. So we want to unify Belizean people.

Then I have here, now, as far as the National Anthem, I would suggest that the legislative body appoint a commission and let that commission take cultural essays and that other means decide or cause people the right and propose as to what anthem we should have in Belize; the words, the music and have adjudicators to say 'O.K. now, this is the better one from among all you Belizeans, therefore, we agree on it.

The national flag; I would say the same. Have a Commission put to the people culturally and then they will say, 'this is the flag that we want.

As far as the emblem within the flag is concerned. The emblem within the flag shows the very sons of slaves who had to use their hatchets and paddle. Now, that in itself is good in a way because it reflects hard working people, but I do not know if they will be conducive to our Independence. I think we should remove something from the emblem and add not only the paddle or the mahogany or the hatchet but add also that predominantly the North plants sugar cane.

What should we remove?

Remove the paddle and we put sugar cane or something that is predominant.

I thought you were dealing with the human on the flag. You said something about sons of slave. I have to understand what you say so I have to ask you what is the reference to sons of slave. I would remove the person who represent slave. History is history; past already. We can't change history. I wish that we could change some of it. But history is a fact, it is a reality; we have to recognize history. That is why these things, every country use

their history. Our history had in slaves so we have to use the history.

Mr. Ayuso:

That is the reason why I am suggesting that now that we are going into Independence, let us see what we can do to unify our people.

CHAIRMAN:

Would that unify them? It doesn't affect my thinking. I am the son of a slave, it doesn't affect my thinking and once the mind is liberated nothing affect us.

Mr. Ayuso:

I want some amendment to the emblem. As I suggested that instead of having a slave there you can put also a man cutting sugar cane.

Mr. Chairman, I am very grateful that you all have come and have listened to me but I really feel that I didn't explain to you what I wanted to explain.

CHAIRMAN:

We have taken your points. You have given us a number of amendments.

Mr. Ayuso: CHAIRMAN: Mr. Ayuso: Well, let me finish with just five sentences. You are permitted.

"Quod Omnes Tangit, ab omnibus approbetur"
"What touches all, should be approved by all"

Oh, yes, no paper should be published. After the Committee reports you can publish it. Thank you, Mr. Ayusa.

CHAIRMAN:

Well, Mrs. Shield, this Committee thank you very much for making your views very clear.

CHAIRMAN:

Please tell us what you want to say on the White Paper.

MS. BAB:

We from the United Women's Group support the White Paper. We would like to include the national prayer, the anthon, the flag with the coat of arms. Then we would like to see the youths to serve an allegiance to the country. We also want to have freedom of women and children. That is all.

CHAIRMAN:

Thank you for making such a clear statement before us.

CHAIRMAN:

MS. PRICE:

Now, Miss Price tell us what you want to say about the White Paper.

I have studied the proposed form put forward by the Government in the White Paper and on the whole is in agreement with it and wish my support for that document to be recorded. I believe that the Constitution should enshrime the national symbols of Belize; namely, the flag, anthem and coat-of-arms.

If you would turn to 4(b) on page 5 - Protection of Freedom of conscience. I think it should include women, children, health and trade unions.

12(b) on page 8 - in my opinion this is somewhat ridiculous. I think that we should have some sort of document or form that could prove that if any other person who has been continuously in Belize for a period of five years immediately prior to the day of Independence does not hold any criminal record or such as in any country. 37 on Page 13: I think 37 here 'The Gowrnor General', he has unlimited nature of power and as far as I am concerned absolute power corrupts absolutely.

58 on Page 17. I feel that 58(a) - I think that the Constitution must be subjected to amendments because every generation has a right to self-determination and I don't feel that our present government should organize the government of our younger generation and the generation to come. They should be allowed to organize their own sort of government.

(b) I feel with this two party setem, it is near imposibility for a majority of 3/4 to be a final vote because we are sure that with this two-party system nothing that our government put forth the Opposition is in agreement with.

Regardless of how good the matter is they will disagree so, the idea of 3/4 majority should be removed from the Constitution.

100 on Page 20: I would like to compliment the government for the Code of Conduct and at the same time wish for them to put more enforcement provision included.

Please tell us what you think about the White Paper?

Mr. Ucan:

We the villagers of San Victor propose the following 4 suggestions: we would like to have our flag to be made the national flag of Belize, our national anthem be the Lands of the Gods and that the national prayer remain the same. Under Section 43: 'A person shall be qualified to be elected a member of the House of Representatives or to be appointed to the Senate if he is a Belizean citizen, eighteen years old or older and has lived in Belize for at least one year immediately before the date of his nomination for election'. We want that all Public Offices should be held by Belizeans, born nationals and also the parents to be Belizeans.

CHAIRMAN:

This Committee thank you very much for coming before it.

CHAIRMAN:

Mr. Orvin Rancharan Ranchito

Mr. Rancharan:

First of all I should say that it is a great privilege for me to address this gathering this morning. And on behalf of the majority of the people of Ranchito I want to tell you all that we endorse the White Paper which is Government's Proposed Constitution for the new and Independent Belizo.

Having examined, I analyze the White Paper critically. We are convinced that it is the sound basis of which the majority of democratic countries operates and we are positive that countless generations of Belizeans yet unborn will look back on the pages of history and glorify the names of our present days Belizeans freedom fighters who have undoubtedly laboured very hard indeed to produce this Bill of Rights which shall be effective, I hope, this year. We believe that any country which praise God first in their national life will inevitably experience peace, prosperity and freedom and this is given priority as I have noted in the proposed Constitution. I want to endorse the proposal that have

been mentioned, I suppose, by other speaker before myself. And they are the inclusion of our anthem, flag. I believe that this should be enshrined in our Constitution because it establishes the Belizean identity.

I am pleased to see that in section 3 of this Constitution there is the human rights and fundamental freedom which guarantees that we have our basic God-given rights and freedom . And while I was on my way here to this Court, I met one of my colleague and he asked me where I was going and I told him that I am coming here to say something on this Constitution; and he asked me to please mention, I think this is where section 3 comes in: liberty, life, security of the person and the protection of law, you know; and he called my attention to the fact that in Santa Clara there have been some very tragic deaths due to lack of enforcement of policemen. I think here it says 'protection of life, liberty, security of the person. I would like very much if this Committee could really see that this is being guaranteed to the people. You want the protection of life? O.K. then.

> Having analyzed this Constitution carefully we noted that considerable power and privileges have been vested in the Governor-General. I think quite a number of people are concerned about that point because they are saying that too much power is given to one person. O.K. then I have said here that considering that so much power is in the hands of a reckless, irresponsible or ruthless persons could create repercussions on the populace. We in Ranchito have proposed some criteria. for the selection of this said Governor-General. First of all, we have here that he should be a Belizean by birth and parentage. I am suggesting at least up to the second generation. We don't want maybe an American come by, give birth and then you know; we want the roots to be here.

CHA IRMA N: Mr. Rancharan: CHA IRMAN:

Mr. Rancharan:

Also I blieve that the Governor-General should show a positive fear of God. I think anybody who has a positive fear of God will be responsible for the actions not only to the people of Bolize but to a higher authority. So this Government, nevertheless, should be definitely God fearing. Should be a God fearing person? It could be a woman too, you know.

I believe that the Governor-General should demonstarate intelligence, and a deep aptitude for administrative work. I'd also like our Governor-General to have been engaged for a long time, working in a hard way for this freedom of Belize. He should have been in this struggle for many many years. We don't want somebody to come here overnight and get this power. We want somebody who really deserves it, to get the power. We have here that he should be humble, patient, and not self-seeking. We don't want anybody to fill their pockets while the vast majority of the population, starves as in the case of Nicaragua. I think our Governor-General should be known and loved and respected by the majority of Belizeans. We don't want no unknown person to be of the helm of Government. We want him to be respected, well known, loved.

Sixth point here, the Governor-General must definitely show that he is bright and that he is good.

I conclude here with saying that, having examined most of the political characters in Belize, we propose that the best complying with most of these criteria, is none other than Honourable Fremier, George Cadle Price, who I'm positive will lead Belize to safe and secure Independence this year. That's all we have.

Then section 44, I want this included, 'a person would be disqualified for elections if he had served two consecutive terms immediately before this election. This will come into effect after independence day (the election after that).

Section 58(b): we want this to be included 'in regard to the provisions relating to Human Rights and Fundamental Freedoms,' no amendment shall be made to the constitution unless 90 days has elapsed. The change I want to do is this 'the bill is approved in the House of Representatives by a unanimous vote.' Page 18, section 64: we are suggesting, or

I am suggesting, that a Representative, a member of the House of Representatives, as well as a member of the Senate, and any Belizan citizen who is a qualified voter, should have the power to introduce bills.

Only members of the House can introduce Bills in any form of Government, but the citizen can ask him to move a Bill for him.

Well, I'm proposing that the Member, the Senator and the citizen have the rights.

How can a citizen do it if he is not a member of the House? You're telling us an impossibility. Any other point?

Yes, it is proper for you to read it but I'll read it for you. I'll ask you to sign this submission for us.

As Mr. Teck makes his first suggestion relating to the Executive; he proposes that 'in the Executive or Cabinet there should exist a balance of power so that no Minister should surpass their powers bestowed upon them as Ministers'.

Secondly, that 'the executive will have privileges and prerogatives in the government so that I suggest that the National Assembly should also have an equivalent privilege and prerogative so that it could check the powers of the executive. In this case the National Assembly should be empowered to impeach any member or members of the Executive who are guilty of robbery, civil offence, faud, criminal offence, cover-up, embezzlements etcetera.

He tinks, thirdly, that 'the National Assembly should also be empowered to form a House Judiciary Joint Select Committee to deal with: the Judiciary matters, the Armed forces and that there should be an Armed Forces Committee, which would deal with disciplinary action, defence expenditure, draft recruitment and that there should be a Joint Committee for Foreign Affairs with the responsibility of confirming Ambassadors named by the Executive. Then he recommends under the Heading 'Free Expression' he says that it is not clarly specified. What I suggest is that each individual should be given the right to put forward his ideas whether it may be social,

religious, commercial or political. This means that every individual should have access to the radio, press or television for the above-mentioned. If this right be denied or neglected, the person has the right to sue the state or private enterprise and that the legislature will not make any laws to abridge this rights'.

Next he goes on to comment on the Election of Members of House of Representatives and he has this to say 'we need to establish that in the Constitution it will be the Supreme Court who will certify every result of any General Elections.

In the Constitution there should exist a law which sets a fixed date for the election of Members of our National Assembly and a fixed date when it expires.

There should also be a fixed date to form the Government which should be Inaugural Day, provided that there is a vote of no confidence which brings down the Government. We accept this in a Parliamentary democracy; that it also be stipulated that every election should be carried out every five years. Date should be clearly specified. Transfer of power from government to government should be on a specific date also; this day should be named Inaugural Day. This should be adopted for 1984 onwards.

Then under the heading 'citizenship' Mr. Teck makes these recommendations 'that any crime committed by the citizen, givil or criminal should be punished by the court but that the State should never have the power to strip any citizen of his or her citizenship'.

Then 'A Military Coup': There should be an impeachment for every military officer who intends to make a coup upon the duly elected Government of the people, the State should have the power to punish him or them, or extradite him from anywhere in the world. Belize should have no military government

under any reason. If the military coup succeeds or fail this would be unconstitutional. This would be a violation on our constitution. Any Member or Members of the military should be dalt with severely by our laws.

Finally, 'In Public Emergencies, Article 7(c)': I suggest that this clause be deleted for this clause endangers the security of our liberty; or, it should be properly defined, in evidence, the types of subversions.

That was the presentation of Mr. Teck.

Well, I have read the White Paper. Iknow it
has some big words I had to look at my
dictionary after reading it.

CHAIRMAN:

I think I support the White Paper and I think Government should go direct with it.

Is there any other comment you would wish to

make?

Mr. Perez:

Well, I don't have anything else to say; and I support it after reading it.

CHA IRMAN:

Well, I wish to thank you very much Mr. Perez for coming forward and letting us know what is in your mind, that is the only way we can find out. Thank you very, very much.

CHAIRMAN:
Mrs. Castillo:

What do you wish to say to us? First of all, the way this Committee is going about taking the opinion of the people, I think it is a little bit unfair, because first of all I didn't think I had a chance to see you, but now you are asking for people to come forward. There are many people who would like to give their opinion on such an important subject as independence. There are a lot of things in the White Paper that we cannot accept.

CHAIRMAN:

Well, the White Paper because our concern is on the White Paper. Would you like to tell us the things you do not accept.

Mrs. Castillo:

First of all, I think it should have been done in simplier words so that more people would be able to understand it. Well, I think that is all I have to say on behalf of my family. Personally - I think that more people should have been able to come in and express their opinion.

CHAIRMAN:

Well, thank you very, very much Mrs. Castillo for coming forward. We are very pleased to hear from you and your family. Thank you. Thank you.

CHAIRMAN:

I am the Chairman of the Cristo Rey Cooperative. I see and thank you very much and thank your Cooperative Association for coming forward.

Herman Sanchez Luciano Tzib Valerio Pott

CHA IRMAN:

And are youall officers of the Cane Farmers Association? May I ask you what office you hold? Mr. Sanchez - Chairman for Belize Cane Farmers; Tzib - Corozal Cane Farmers Pott - Representing San Victor Branch. So you are all from the Corozal Executive Right?

Well, thank you for coming forward and you are representing the Association am I correct? Would you please tell us what the Association thinks about the White Paper?

Well, first of all, going through this White Paper there isn't anything that we can be against: just include national flag, national prayer, national anthem. We want the blue and white flag to be our national flag to be put in the Constitution; that the term of office should be no more than five years. That is for the House of Representatives. We from the Association support the White Paper.

He would like the national anthem, national prayer and national flag to be included. We thank you very much Mr. Carasco for coming before us.

Valdemar Castillo Corozal Town

CHAIRMAN:

Mr. Castillo:

Mr. Valdemar Castillo, you are representing the people of Corozal North, right? Chairman and members of the Commission, I sincerely believe that this is a good document, the White Faper and I personally support it.

Just for clarification sake, I would like to ask two questions; the first one is on Page 8 - No. 12 Part (b) - just a little clarification: Any other person who has been resident continuously in Belize for a period of five years immediately prior to the day of Independence, what I want to know is this: the person involved will have to be residents - would they have to have a residential document? First of all, I would like to answer it generally and say that here we contemplate that there is going to be a citizenchin.

CHAIRMAN:

which is going to support and back up the things which are said here and is going to amplify very much more closely and in detail all the requirements that are going to be made of any person who claims either citizenship or the right to registration. That's the first I would like to say; we could not possibly put down all the details here. What we have attempted to do is to set out just the principles of those people who would be able to make an application T for registration. That's what these are about; people who would be able to make application. It doesn't mean it will be necessarily be accepted. There would be qualifications set out there. There would be details there. There would be specification as to what they must do. But in general, what we are talking about is a person who has been continuously residents and can prove it. That person should have been registered as an Alien, but the fact that he or she has not been registered as an Alien wouldn't preclude that person from coming forward and proving good conduct. Proving good conduct and good behaviour and all the other requirements which would be a law that would back up the constitution.

Mr. Castillo:

CHAIRMAN:

I accept it.

The other thing is on Page 10 No. 21 Thy are talking about the Attorney-General,
I just wanted to get it a little clear whether
the Attorney-General would be from the House
of Representatives or will he be someone
from outside of the House?
The Attorney General will be a Member of the
National Assembly, might necessarily not be
from the House of Representatives, he might
be from the Senate, but he would have to be
a member of the National Assembly and he would
be a Minister. As our present Attorney
General that's what is contemplated there.
The Public Officer would be the Director
of Public Prosecutions.

Finally, I would like to request that in this White Paper, as we are a Christian Community, Christian Country and everyday we pray to the creation for guidance and protection that we include the Belizean national prayer; and I would also like to request that we include the symbols of Independence which is our Belizean national anthem'Lands of the Gods' and the Belizean national flag, which is the blue and white flag with the sub umpra floreo in the centre. Thank you very much for coming forward and giving us the benefit of your time.

Select Committee:

After studying the Proposals for a Independence Constitution it is crystal clear that Government intends to establish a dictatorial Government.

Sec. 21 dealing with Attorney General and Sec. 37 dealing with Governor General and Prime Minister and many other sections clearly indicate the above.

If Government intends to provide citizens with a constitution that elevates Attorney General, Governor General and Prime Minister above the LAW this document must be considered dangerous, treacherous, and not of good faith.

Therefore, THE PEOPLE OF COROZAL, because of the lack of confidence in the Illegal Government and because of the fact that they understand that a satisfactory settlement must be secured on the Guatemalan claim and because they demand that their must be a proper defense guarantee and not a Shimmay-Shammy promise by the British to protect us for a very limited time after independence and because they also demand that the Electorial System be revised, categorically refuses to offer any suggestions to improve the "White Paper" proposals for a constitution.

THE PEOPLE OF COROZAL also demand based on experiences in the last sixteen or more years of rule by the P.U.P. Government that the present Government be disolved before any further steps are taken to plunge their Country into a dangerous and most unsafe Independence. If the Government has any doubts of the feelings of the people, a properly supervised Referendum will clearly prove the people dissatisfaction.
