CHAIRMAN

The Committee is authorised by resolution
passed in the House and Senate of the
National Assembly and directed this committee
to canvass the opinions of the Belizean people
before presenting its final report to the
National Assembly.

Hon. C.L.B. Rogers: the Committee on the hearings on proposals
for the White Paper, begins. It is my duty to remind citizens
that the terms of reference of this committee, indeed the authority
of the committee, stems from a resolution of both the House and
the Senate to create a joint committee to hear the views of
citizens on the proposals contained in the White Paper. Therefore
the comments before this committee, the committee is empowered
only to hear comments on the proposals, either that you are for
or against or that you wish to change or wish to add proposals,
~~That is~~ the terms of reference of this committee. Any other
matter is out of the terms of reference. We therefore begin at
this meeting, but we would like to remind any member of the press
who may be present that the hearings of these committees, should
not be published under the law, under the standing orders of the
House until the committee reports to the House. These hearings
are still not to be published and that anyone who violates that
will be subject to prosecution. Having said that, it is now my
duty to call on the first person to come before the committee and
I have a list of names here. The first name is that of Ida
Ida Castillo and who is the other person?

Ida Castillo:

Carrie Muslar

Hon. C.L.B. Rogers:

Do you represent a group or

Ida Castillo:

Hon. C.L.B. Rogers:

Miss Castillo and Miss Muslar, that machine is going all the
time and will record what you have to say. Members of the
committee, may from time to time have to stop you. What would

you like to say to the committee on the White Paper?

Ida Castillo:

Please convey to our dedicated and able Premier, that we the United Women's Group of Dangriga support the White Paper and Independence we are to achieve, including (1) our National Prayer (2) our National Anthem (3) our flag. Long reign our Premier.

Hon. C.L.B. Rogers:

Thank you very much. Any questions, members of the Joint Select Committee.

Hon. S. Musa:

The submission is very clear.

Hon. C.L.B. Rogers:

Then it is my duty to thank you on behalf of this committee for a very clear submission to the proposals. Thanks.

Ida Castillo:

Thanks.

Hon. C.L.B. Rogers:

The next name on our list is that of Stella Avilez. We have your name but can you tell us your address?

Stella Avilez:

16 Canal Street, Dangriga

Hon. C.L.B. Rogers:

Miss Avilez, you appear as a representative of a group or a citizen?

Stella Avilez:

A citizen.

Hon. C.L.B. Rogers:

Yes, please do tell us now your views.

Stella Avilez:

I'm in favour.

Hon. C.L.B. Rogers:

You support.

Stella Avilez:

for the country of Belize.

Hon. C.L.B. Rogers:

Is there anything else you would like to tell us?

Stella Avilez:

That we should stand firm and become independent of our country, by the help of God, and the church of the Honourable Premier of Belize and that we should ride under one God to see and enjoy the benefits of the country.

Rogers:

Thank you Miss Avilez. , I would like to thank you on behalf of the Committee. The records will show that. As we've heard Miss Avilez, the next name is Elojio Sho. We have your name. What, you represent a group or....

E. Sho:

As Chairman of my village, Maya Centre.

Rogers:

Mr. Sho, please proceed to tell us your views.

E. Sho:

Well, I received the White Paper some time ago, and I put it to my people and they told me that there is nothing wrong with it except one thing, that the National Anthem, the flag and the Prayer should be included .

Rogers:

You propose that the National Anthem, and the flag and the National Prayer should be included.

E. Sho:

And I wrote one of the letter and I give it to the Minister.

Rogers:

I think we have it right here. We have a number of written submissions.

E. Sho:

That's all I have to say. We support the White Paper.

Rogers:

Please convey to your people the thanks of this committee and that you came forward with very clear submission. Thank you very much. The next name is Mr. John Noralez. I'm putting them in order, the order in which they came. Mr. Noralez, we have your name, we need your address.

J. Noralez:

No. 53 Amagarugu Road, Dangriga.

Rogers:

And you appear on behalf of others or as a citizen.

J. Noralez:

On behalf of the People's United Party.

Rogers:

Please tell us your views Mr. Noralez.

J. Noralez:

Our views is that, all of us will be happy when the day come for us to get our independence.

Rogers:

You support the White Paper?

J. Noralez:

I support the White Paper.

Rogers:

Anything else Mr. Noralez?

J. Noralez:

No. I think I've come to the end.

Rogers:

Good. I would like to thank you on behalf of the committee for coming before us. The next name on this list is that of Mr. Alonzo B. Ogaldez. Shall we get the names of the others please.

We have your name but not the others. Miss Cecilia Aranda, Kr. Kelvin Lino, Mr. Orlando Castillo, Mr. Joseph R. Palacios, Agnes Arana, Daniel Castillo and Mis. Claudina Danius. Is there anyone else? No.

Rogers:

And you're representing.....

A. B. Ogaldez:

We are representing the United Democratic Party, Dangriga Branch.

Rogers: Now please give us your comments on the proposals of the White Paper.

A. B. Ogaldez:

These are the amendments to the White Paper/ No. 1, the preamble to the Constitution should contain a clause rejecting the position of any systems of Government that denies Human Rights and for the Fundamental Freedoms with citizens. The systems of Government, I'm referring to here are communism and dictatorship.

Rogers:

So that the Preamble should contain a clause that denies Human Rights and for the Fundamental Freedoms with citizens. Please proceed sir.

Ogaldez:

No. 2 Section 3 of the White Paper. Human Rights and Fundamental Freedom. It is very heartening to see that these basic rights are written into these proposed terms of the Constitution rather than they be taken for granted. To these basic rights, should be added 'Freedom from want and insecurity. The right to employment health, education and leisure'. I particularly mention freedom from want and the right to employment, because it has been the experience in many developing countries that only members of the political party in Government are entitled to employment in both the public and private sectors and therefore only those members are to be free from want, it would appear. This idea that only

members of the party in power. This idea has been expressed time and time again in the popular saying which goes something like 'we will reward our friends and punish our enemies' which saying has been attributed to party in Government.

Rogers:

Proceed.

Ogaldez:

Section 4(i)

Rogers:

Yes, Protection of freedom of expression.

Ogaldez:

This section should include rights of citizens to operate private Radio and television stations subject only to regulations for the purpose of orderly operations. Citizens should also be entitled to express and hear diverse and opposing views in newspapers, radio and television.

Rogers:

Go on.

Ogaldez:

Section 4(n) Protection from deprivation of property. We feel that this section should make room for citizens whose lands are acquired by Government to have access to the court to challenge the public purpose for which the land is being acquired. Section 16.

Rogers:

Section 16. And that is on the Governor-General.

Ogaldez:

We feel that the appointment of the Governor-General should be made after consultation with both the Prime Minister and Leader of the Opposition or the Advisory Council. Preferably, by the Advisory Council. The reason for this, of course, is to guard against the obvious danger of political influence.

Rogers:

We have your points.

Ogaldez:

Section 33.

Rogers:

33, The Belize Advisory Council

Ogaldez:

We propose that the name should be changed to 'The Belize Council of State', and we further suggest that the membership of this body be appointed from citizens of the following categories:
Category A - former Ministers of Government, former Leaders of

the Opposition, former Speakers of the House of Representatives and former Presidents of the Senate; Category B - Belizean citizens who formerly held the office of Chief Justice, Judges of the Supreme Court and Court of Appeals, Attorneys at law with status of senior Counsels; Category C - Ten other persons.... who are citizens of Belize.

Rogers:

No other qualification?

Ogaldez:

Not below the age of 30 years, six of whom to be nominated by the Prime Minister and four to be nominated by the Leader of the Opposition. Section 40.

Rogers:

The Minister is trying to understand your proposal and he would like to

Ogaldez:

I would say one of each category. I mean, not one of each category; one of each in the category; one from (a) one from (b) and one from (c).

Rogers:

Does that hold similarly for (b)? former C.J.....

Ogaldez:

Yes.

Rogers:

He says that there is no former C. J. and Belizean citizens...

Ogaldez:

Yes, I agree.

Rogers:

So then your total for the membership of that will be ten, plus one, two,

Ogaldez:

I haven't finished with (c), six of whom should be nominated by the Prime Minister

Rogers:

Very well Sir, you now turn to question 40.

Ogaldez:

We feel that this section should be completely deleted

Rogers:

Section 40 should be deleted. Let us see that. The proposals before this committee is that section 40 be deleted.

Ogaldez:

Section 41. We suggest that the division of the constituencies

be made before independence and the membership in the House of Representatives be determined by that division prior to independence and the membership in the House of Representatives be determined by that division prior to independence day and that no more than one half less 2 of the membership in the House of Representatives may belong to the Cabinet at any one time.

Rogers:

....and that no less than one half. Less 2 which comprise the membership the

Ogaldez:

Section 58. For the amendment of the Constitutions, we recommend that it should be not less than the support of three-fourths of the membership in the National Assembly.

Rogers:

Your proposal is that any amendment should require three-fourths.

Ogaldez:

Three fourths of the membership of the National Assembly, and the Premier.

Rogers:

Yes.

Ogaldez:

Section 75 - we urge strongly there that the appointment of the Chief Justice be made after consultation with both the Prime Minister and the Leader of the Opposition.

Rogers:

Yes?

Ogaldez:

Section 86 - The Public Service. We suggest there that the appointment of the Civil Service Commission be made on the advice of the Belize Council of State (Advisory Council). Just before I conclude, Mr. Chairman and members of the Committee, I would like us to go back to the Preamble. Can I say that it should be amended by

Rogers:

That it should contain a clause.

Ogaldez:

contain a clause. We urge that this very important clause be written into the constitution in order to realize the truth in the saying that eternal vigilance is the price of liberty because itself will represent that eternal vigilance.

Rogers:

Any member has any questions to ask Mr. Ogaldez?

Hon. Fred Hunter:

The question I would like to ask under 16. Suppose the appointment of the Governor-General in consultation with, but not the Prime Minister being on the Advisory Council, find that the Governor General being appointed on the advice of the Advisory Council and the Advisory Council has the Governor-General as its Chairman, how will you go about that?

Ogaldez:

The Advisory Council has the

Hunter:

Governor-General as the Chairman. How will you appoint the Governor-General?

Ogaldez:

Well, we have a Protem Chairman

Hon. S. Musa:

Who appoint the Protem Chairman

Ogaldez:

Members, from among themselves.

Rogers:

Any other question?

Musa:

Other than the observations and suggestions you made, you find the White Paper acceptable?

Ogaldez:

Well, since there are no alternative, really

Musa:

You have other things you want to recommend?

Ogaldez:

That is what was contained in the conclusion which the Chairman had struck out.

Rogers:

How long would you require to study a document?

Ogaldez:

An important document?

Rogers:

Yes, how long?

Ogaldez:

A reasonable time. A time considered reasonable by a usual man.

Musa:

A matter of time; you know the committee can make submissions, when I say committee, your committee, can make submissions in any other district apart from Dangriga. As a matter of time, if you feel that you are pressed for time, you can make your

submissions in Corozal District next or Orange Walk.

Ogaldez:

I intend to make submissions on the others, I hope.

Rogers:

Yes?

Hunter:

Under The Belize Advisory Council, it says, 33. There shall be in and for Belize a Belize Advisory Council which shall consist of a minimum of six members appointed by the Governor-General on the advice of the Prime Minister. Now, how will this Advisory Council that has not been appointed by the Governor General, appoint a Governor-General?

Rogers:

The Minister is asking you a question. Put your proposals in prospective.

Ogaldez:

I get your point, Minister. The thing is that once the Governor-General has been appointed.....

Hunter:

You want the Advisory Council appoint him?

Ogaldez:

Yes.

Hunter:

Does it exist because the Governor-General is appointed by the committee? How do you solve that?

Rogers:

One come before the other Mr. Ogaldez. It is formed by the nation.

Ogaldez:

That's why I didn't try to study it.

Rogers:

Any other question? Why would you want to change the name to 'Council of State'? So we can have the reason put in.

Ogaldez:

Well, it gives it an aura of international recognition.

Rogers:

State? Council? as against... It is a national thing you know. It has nothing to do with international offence; strictly with Belize.

Ogaldez:

I know, but...

Rogers:

The functions will be the same, the importance of a thing is like the rose that if you name any other thing it will still be a rose.

Ogaldez: That particular name will find itself in international documents and so on.

Rogers:

Is there any other question? If there is none then I should thank you, Mr. Ogaldez for coming here.

Ogaldez:

So you are not accepting the

Rogers:

Yes, we are accepting your paper, except the one... the one with the proposals.

Ogaldez:

You have the name of the,...

Rogers:

We have the other names. Thank you.

Chairman:

Well, Miss Ramirez, this committee wish to thank you for your appearance before this committee. Please convey it to your people.

Mr. Felicito Calam

Chairman:

Mr. Calam, could you tell us what you think of the White Paper?

Mr. Calam:

On behalf of my villagers and myself we accept the White Paper. We would only want to see added the National Flag, the National Anthem and the National Prayer.

Chairman:

We would like you to convey to your people the thanks of this committee.

Mr. Henry Bowman, Jr.

Pelican Beach

(Citizen)

Chairman:

Could we have the benefit of your views, Mr. Bowman?

Mr. Bowman:

It is certainly a very good White Paper to begin with. And I want to make sure that when it comes to the Paper - page 23 - 88 I would like to make sure that that stays in because sometimes Civil Servants get the impression that they own the Government. On page 14 - 43. A person shall be qualified to be elected a member of the House of Representatives or to be appointed to the Senate if he is a Belizean citizen.

Chairman:

You would like the word "born" before "Belizean citizen".

Bowman: I know that this Paper separates the Courts from the Government. We would like the independence of the Judiciary maintained. I like that and would like that left in.

On the matter of the Belizean flag.... I would like that to be included; but somewhere in your wisdom you can create greater unity by injecting some other symbol to the Flag. This would be appreciated, but I am not stressing it. But for the sake of greater unity, if it would at all be possible.

Hon. F. Marin:

What about the Anthem?

Mr. Bowman:

The Anthem is very good. I haven't heard much objections to the Anthem; I haven't heard of any other proposed Anthem. And the Prayer is a very beautiful Prayer.

Chairman:

Any other questions, Members? If not, Mr. Bowman, let me thank you on behalf of the committee for coming here today.

Mr. Russel Garcia

16 Ghans Avenue

(Citizen)

Chairman:

Could you give us the benefit of your views, Mr. Garcia.

Mr. Garcia:

As I examined the White Paper, to my mind I find that there are certain things within the Protection of Human Rights and Freedoms - Page 3. I find that when I look at (h) on page 5, I find that there is one called "Protection of Freedom of Conscience." Well I am of the opinion that freedom of conscience is inherent within a man, meaning that my factual situation with me and I, no one will know. So it occurs to me that there is no need, no reason at all why freedom of conscience should be written in, because everyone has freedom of thoughts and conscience or to whatever religion they want to be.

When I examine the word "religion" again, I find that there are established religions that we call religion in Belize, but there is also now, what I will call the African tradition, taking its roots, as I refer to I and I, kastafari. And I have found throughout the Caribbean countries I have gone to that the kaste has always been outlawed. This could be the situation as I see it in Belize because it has already taken roots. I am not

accusing anyone of such and that is why I would like to have written into (h)....

Chairman:

First I thought you wanted this out.

Mr. Garcia:

No. I would like it amended. I would like this - "Protection of Freedom of Conscience and Tradition". If it was left to I and I, I would have taken it out still because conscience, as I told you, no really no, but because of Rastafari I put in the word "tradition" because I and I have no religion as such.

Chairman:

Anything else?

Garcia:

Within that same thing, I have not seen a thing called - I've seen one called "Protection of Human Rights" and protection of citizen and protection of person, but there is not one written here for the protection of Belizean youth. I would like this to be written in...."Protection of the Belizean Youth".

With a view for the development of agricultural institutions that will ensure that the Belizean youth has a proper respect for the dignity of labour which is deteriorating today.

Chairman:

You want a work ethic in there.

Mr. Garcia:

Truly - put that in there

Chairman:

No, no! This is a serious proposal. The work ethic should not be forgotten.

Mr. Garcia:

Along with that same situation, we have a proper development of human resources. I, at this point, would like to refer to an institution in Belize that I have attended - Lynam Agricultural College - which in I and I view, if we had more of that or if we had that one existing, we'll have more youths with more balanced development instead of this discomiac situation which is arising.

Chairman:

It is giving way now to a thing called "Country and Western"; I don't know which is better; but discomiac is disappearing.

Mr. Garcia:

You think so?

Chairman:

Yes, they are bringing in a mechanical bull.

Mr. Garcia:

I see people tired every Saturday night.

Chairman:

It takes long to get to Belize....It's coming.

Mr. Garcia:

It's coming in. Well, that's how the man see it.

Chairman:

Anything else?

Mr. Garcia:

No, I won't say anything more.

Chairman:

If not, I would like to thank you for bringing your views.

Hon. F. Hunter:

Do you support the White Paper?

Garcia:

Well, until such and such has been written in.

Hon. G. Ramos:

You support it with the amendments you have made.

Mr. Garcia:

Yes, but until such and such has been put in.

Chairman:

All you want included are those; that's what I understand you told this Committee; please include these matters.

Hon. S. Musa:

I just want to make this point - when we talk about citizens we include the Belizean youth.

Mr. Garcia:

Oh, just before I finish off, there's another thing I want to put in.....within the same 'protection of tradition', what I have noticed is what I call 'isolation of peoples on reserves' in Belize.

Chairman:

Isolation of peoples on reserves. Yes.

Mr. Garcia:

As I see my history, I hear of a Carib Reserve and hear of an Indian Reserve. To me, I think these reserves should be de-reserved and open and a proper land-holding situation be instituted. That is all within the 'protection of tradition'.

Chairman:

Well, those are your views, Mr. Garcia, and we will take account

of them. Bearing in mind that reserves in this Country doesn't mean like the reserves in South Africa, or the Indians in North America; they go and they come as they like; and as I understand it, it's a lot of the older people who wanted it; the younger ones want title to their land for collateral; they lose it to the banks later, but they want the right to do what they want.

Mr. Garcia:

What is happening here right now - a lot of youths would like to work the land; but their parents thought that they owned the land and they never really owned the land. So most people down here don't really own land.

Chairman:

Well, Mr. Garcia, we thank you for your clear views.

Mr. Garcia:

Truly.

Mr. Allan Partis, Jr.

47 Front Street

(citizen)

Chairman:

Could you please give us the benefit of your views, Mr. Partis.

Mr. Partis:

Frankly speaking, Sir, I have gone through this White Paper and I don't fully understand the contents or the real value of this White Paper. And as far as I could observe, most people who came here saying that they support it, doesn't really understand it either. To me, the contents of this White Paper is written in a more or less advanced stage of English that it could confuse people who don't understand.

Chairman:

You have any proposal to make about it?

Mr. Partis:

The proposal I would like to make is this - it could be re-written.

Chairman:

You would like a condensed....Partis would like it condensed and simplified. Alright, Mr. Partis, that is your proposal.

Mr. Partis:

Secondly, we as youths are anxious to know what kind of Government we will have after Independence?

Chairman:

I see. The White Paper doesn't bring it out to you. You have no proposal to make on that?

Mr. Partis:

The proposal I would like to make is that that should be included.

Chairman:

Simplification and include type of Government.

Mr. Partis:

Why this arise is if you look at Section 30 - "There shall be a Leader of the Opposition who shall be appointed by the Governor-General. He shall be the member of the House of Representatives, who in the judgement of the Governor-General, is best able to command the support of a majority of those members who do not support the Government. Or if there is no such person, the member who commands the support of the largest single group of members opposed to the Government." What I understand this to mean is that the Leader of the Opposition will not be appointed by the people again.

Chairman:

That's what you think, that's not correct.

Hon. G. Ramos:

You do not understand what you are reading.

Mr. Partis:

But it says "appointed by the Governor-General".

Chairman;Everybody is, so is the Prime Minister.

Mr. Partis:

Then there'll be no election?

Chairman:

No. You don't understand what you are saying. It's after an Election; after an election is finished the Governor-General calls before him - just like now; the same thing happens now - and say let us see who commands the support of the majority; let us see who commands the support of the minority; and he names the Prime Minister from the first one and the Leader of the Opposition from the second. It has to be; you didn't read the paper. It says to you that it is after an election; after an election is finished then the Governor-General does those things. Anything else, Mr. Partis?

Mr. Partis:

Well, I would just like that my proposals would be included.

Chairman.

Yes, we have those. A simplified version. Thank you Mr. Partis for coming before this Committee.

Mr. George Westby - Vice-Chairman of Village Council

Chairman:

Mr. Westby, could we now hear your views on the White Paper?

Mr. Westby:

I've got one of the White Paper; We have read it over and over, and we go along with the White Paper one hundred percent. On behalf of myself, I have to say that we had confidence in our Ministers in the beginning of advance constitution; we got advance constitution and we are going into independence. what I consider, adequate amendm nts. On
page 5 Section 4 (5) This right to freedom
of expression shall include the right of
citizens to operate private newspapers,
magazines, radio stations, television
stations, subject only to regulations
necessary for orderly operations.

Page 8 Section 14. A Belizean citizen should lose his citizenship by renunciation and by no other cause. He should retain his citizenship unless he specifically indicates he no longer wants such citizenship.

CHAIRMAN:

That means you can be a Guatemalan and a Belizean.

ARZU:

No man, wait, wait.

CHAIRMAN:

There is no difference, if you are saying that the only way to lose his citizenship it means that if the Belizean carrying a Guatemalan Passport or nationality, he can't lose his Belizean citizenship because he hasn't renounced it. Just think carefully before you put the question.

ARZU:

The Belizean can lose his citizenship by renunciation and by no other cause.

CHAIRMAN:

That means he can be both a Guatemalan and a Belizean. You are proposing that.

ARZU:

I am proposing that.

CHAIRMAN:

You are proposing that. All right.

ARZU:

Page 12 Section 33. Change name to Belize Council of State. The Belize Council of State shall be comprised of three categories of membership as follows:

(a) Any person who since the advent of self-government has had advocated the office of Premier, Deputy Premier, Minister of Cabinet, Leader of the Opposition and Deputy Leader of the Opposition, Former Speaker of the House of Representatives and former President of the Senate; (b) Any Belizean who has office of Chief Justice, Puisne Judge, Judge of Court of Appeals, Registrar

General, Attorney-at-law with status of Senior Counsel. (c) Ten other persons not below the age of Thirty, appointed by the Governor-General, six on the advice of the Premier and four on the advice of the Leader of the Opposition. The Governor-General shall be Chairman and three members from each category constitute the quorum; we are suggesting broader council of state; a broader ministry following the suggestions.

MUSA:

Will that be practical, look at (b)?

ARZU:

Well, it is a suggestion coming from me.

CHAIRMAN:

Go ahead Mr. Arzu.

ARZU:

Thirty-three. There shall be a Judicial Committee of the Council of State which shall comprise of the councillors of state under category (b) and such other councillors who are attorneys-at-law.

Page 13 Section 41. Each member of the House should represent not less than one thousand five hundred nor more than three thousand voters. There should be a Boundaries Commission of the House to supervise the establishment of constituencies. Page 14 Section 44 should be amended to read:

A Person shall be qualified to be elected to be a member of the House of Representatives or be appointed as a member of the Senate if he is a Belizean citizen 18 years old or over and has lived in Belize before the date of his nomination or election and is able to speak and read and write the English Language.

Section 17 Page 58. A vote of three quarters of the membership of each House of the National Assembly should be required for amendments of any provisions in the Constitution. Amendments of entrenchment clauses should require in addition a referendum under the Jamaica formula. No amendment shall be made to this constitution to provide that Belize shall be a one-party state. The right to form and join a political party shall be entrenched in this constitution as a Human Right. Page 17 Section 59. Standing Orders shall among other matters make provisions for the following: (a) the right of members to move motions and to speak on such motions at the time of presentation; (b) Requiring the Chairman of each committee to submit monthly progress report as Sessional Papers on all Bills, Motions and other matters pending before his committee together with reasons explaining why there has been a delay of more than one month in reporting back on any such bills, motions or other matters to the House. That the Leaders of the Opposition or someone appointed by him shall be Chairman of the Public Accounts Committee shall contain a majority of members for the Opposition Party. (b) That when a Minister introduces a Bill for the first reading he shall at the same time lay a copy of such bill on the table.

Page 19 Section 73. (a) A bi-election to fill any vacancy in the House of Representatives created by death resignation, death or otherwise of the member shall be held within six weeks when such vacancy occurs. Provided no bi-election shall be held if such vacancy occurs less than three before the life of the Assembly is due to expire by operation of the law. Page 20 Section 77. The question of the removal of the Judge be referred to Her Majesty the Queen to the Judicial Committee of Council of the Crown. Page 21 Section 80. The question of the removal of the Judge of the Court of Appeal shall be referred to her Majesty the Queen of the Judicial Committee of the Council of State. Page 21 Section 82. The term "Her Majesty the Queen in Council" is understood in this context to mean Privy Council in England. Perhaps this should be clearly stated. Page 22, Section 84. The removal of the Director of Public Prosecutions shall be referred to the Judicial Committee of the Council of State. Page 23, Section 89. And all other sections dealing with appointments to be made by the Governor-General on the advice of the Prime Minister should include the following proviso: Providing that the Prime Minister shall not present the names of any person the Governor-General for appointment unless his nomination of that person has been ratified by the Joint Committee on appointment of the House of Representatives and the Senate and by positive vote of

both Houses.

MR. ARZU:

Page 24, Section 91. Appeals on matter relating to Public Service shall lie with the Council of State.

Page 26, Section 98. The question on the removal of the Auditor General shall lie with the Council of state. Page 26, Section 100; Council of State shall be included in this section. See that no guilt shall be passed to all its stages on the same day except with unanimous consent of all members present.

CHAIRMAN:

What is it you wish to say?

MR. ARZU:

Thank you very much.

CHAIRMAN:

You are not commenting on the proposals and that's what we are here for. Any questions, members?

MUSA:

Mr. Arzu mentioned something about a referendum on the Jamaican family, what do you mean?
