for

AN ACT to amend the Representation of the People Act, Chapter 9 of the Substantive Laws of Belize, Revised Edition 2020; to give effect to the Redivision Report of the Elections of Boundaries Commission by varying boundaries and removing and creating electoral divisions in Schedule I of the Act; and to provide for matters connected therewith or incidental thereto.

BE IT ENACTED, by and with the advice and consent of the House of Representatives and Senate of Belize and by the authority of the same, as follows:

Short title.

This Act may be cited as the

REPRESENTATION OF THE PEOPLE (AMENDMENT) ACT, 2024,

CAP. 9. and shall be read and construed as one with the Representation of the People Act, which is hereinafter referred to as the principal Act.

Amendment of section 17. Section 17 of the principal Act is amended by inserting after the word "into", the word "thirty-one".

Repeal and replacement of Schedule I. 3. Schedule I of the principal Act is repealed and replaced with the following-
