**I BILLS FOR SECOND READING**

1. Insurance (Amendment) Bill, 2024.

Bill for an Act to amend the Insurance Act (Act No. 30 of 2023); to provide for realignment of terminology and internal cross-references and to amend the provisions for the disclosure of beneficial owners; and to provide for matters connected therewith or incidental thereto.

*(The Honourable Prime Minister and Minister of Finance, Economic Development, Investment, Civil Aviation, and Immigration)*

2. Disabilities Bill, 2024.

Bill for an Act to promote, protect and ensure the full and equal enjoyment of privileges, interests, rights, benefits, and treatment by persons with disabilities on an equal basis with persons without disabilities; to establish the National Commission for Persons with Disabilities; to establish the Disabilities and Equal Opportunities Rights Tribunal; and to provide for matters connected therewith or incidental thereto.

3. Anti-Sexual Harassment Bill, 2024.

Bill for an Act to make new and robust provisions for the prevention and protection of persons from sexual harassment; to provide for a right of redress for any person who has been sexually harassed; to repeal the Protection Against Sexual Harassment Act, Chapter 107 of the Substantive Laws of Belize, Revised Edition 2020; and to provide for matters connected therewith or incidental thereto.

4. Southern Deep Port Development Facility Bill, 2024.

Bill for an Act to provide for certain exemptions from taxes and duties proposed to be granted to the Southern Deep Port Development Ltd. by the Agreement; to provide for the effective implementation of the Southern Deep Port Development Facility; and to provide for matters connected therewith or incidental thereto.
